2. Progress in implementing Objectives, Actions and achieving KPIs

Since the last meeting of the European Scout Committee

AC 8.1.1 – IN PROGRESS

Encourage NSOs/NSAs to participate in the creation and development of National Youth Councils

Progress:

- Active support to the Serbian Scout Association in the establishment of the NYC in Serbia (KOMS). KOMS is in the process of being a member of YFJ
- Bulgaria National Youth Council is in the process of becoming a member of YFJ.
 The region supported, informally, some years back, the Scouts to be part of the platform. One Scout is in the board of this platform.

• The involvement of WOSM in the preparation of the European Year of Citizens in 2013.

On 11 August 2011, the European Commission proposed to designate 2013 as the "European Year of Citizens" to mark the 20th anniversary of the establishment of the European Union Citizenship under the Maastricht Treaty in 1993. European civil society organisations and networks members of the EESC Liaison Group have created a civil society Alliance aiming to advocate on MEPs for a broader understanding of European citizenship within the proposal to designate 2013 the European year of Citizens. The Alliance benefits from the support of the European Economic and Social Committee and is aiming, in the long run, to mobilise and coordinate wide civil society engagement in the activities which will be scheduled during the European Year of Citizens 2013, to initiate a European-wide debate on issues relating to the exercise of European citizens rights and to citizens' participation in the democratic life of the EU. The Alliance is open to all civil society organisations sharing the same vision and willingness to promote a collective engagement for a common project and the emergence of a European public space.
