1. Introduction

2. Progress in implementing Objectives, Actions and achieving KPIs

Since the last meeting of the European Scout Committee

• AC 8.1.1 – IN PROGRESS

Encourage NSOs/NSAs to participate in the creation and development of National Youth Councils

Progress:

- On going: KOMS is in the process of becoming a member of YFJ and compliance with the membership criteria. Planning the continuity of Scout representation in NYC. At the present moment one Scout is in the Board of the NYC and the Secretary General is also a Scout.
- On going: Bulgaria National Youth Council is in the process of becoming a member of YFJ. The region supported, informally, some years back, the Scouts to be part of the platform. One Scout is in the board of this platform.

- YFJ Following and contributing to:
 - The definition of the next 6 years priorities of the platform adopted at the spring Council of Members' Meeting
 - Youth rights debate awaiting the publication of the study carried out by YFJ
 - Volunteering : EYV and European Charter of the rights of the volunteers
 - Youth in Action: WOSM is represented by a volunteer in an expert group looking at our contribution for the next Youth in Action programme. We also coordinate the exchange of activities and actions of INGYOs inside YFJ. As a result of this coordination, an open letter explaining the necessity of admin grant in the next cycle of the multiannual financial framework was sent to all partners. WOSM role in the process has been highly praised by partners.
 - Contribution to policy papers on UN and Global Youth Work Development, Structured Dialogue and New Media and Internet Governance.

Cooperate with the European Parliament, European Commission, Economic and Social Committee on relevant topics and hold meetings with Scout representatives

Progress:

- European Parliament: Alix Masson, for WOSM, was invited to speak about EYV2011 at the Hearing on Youth and Volunteering organised on February 9 at the EP by the EPP group, under the leadership of MEP Marco Scurria. The Hearing was attended by over 150 people
- Planned working lunch with two EESC Members to further the work with WOSM (Pavel Trantina and Kryztof Pater)
- In the planning of a hearing or round table at the EP, in the autumn (about euro Africa cooperation and youth in action)

AC 8.2.2 – IN PROGRESS

Encourage and convene annual meetings of the 'Big 6' youth organisations in Europe to discuss issues of common interest

Progress:

 At the YFJ COMEM the meeting of 5 of the Big 6 organisations took place. The necessity of the meeting following the first seminar in 2009 was discussed. Our partners are expecting WOSM to take over the leadership role in the organization. However, the format and the content of such meeting are still under discussion. A viable option proposed by the Core Group is opening one of the Regional events to the representatives of Big 6.

• AC 8.2.3 – IN PROGRESS

With NSOs/NSAs, review and develop policy positions on issues relevant to the needs of young people including employment, mobility and human rights

Progress:

 After the adoption of the PP on Volunteering, the CG has started to develop the policy position on employment and human rights.

- 28.10-31.10.2012 YFJ is organizing an NFE week with a focus on Employability. WOSM participation is highly important.

- Preparing a contribution to the Chief Executives' Meeting on the recognition of Scouting and funding of activities of Scouting.
