Final Accounts of the European Region for the Year Ended 30 September 2011

Dear friends,

I am pleased to attach the Auditors Report for the European Region for the Fiscal Year ended 30 September 2011, comprising of:

- European Region (Geneva)
- Bureau Européen du Scoutisme ASBL (Brussels)
- Fund for European Scouting.

I am pleased to inform you that the audit has been completed without the expression of any reservations or qualifications from our auditors, Ernst & Young.

We are conscious that this circular has been somewhat delayed and in total transparency, I would like to bring to your notice the following:

The Fiscal Year ended 30 September 2011 was the first year that the European Investment Fund (EIF) was created and operated under the responsibility of the European Scout Foundation (ESF), following the announcement to establish the Fund that was made at the European Scout Conference in Brussels in July 2010. Due to the market downturn during the Fiscal Year ended 30 September 2011, the EIF has incurred an unrealised loss which, according to the accounting standards and policies (concerning the valuation of assets), had to be reported in the financial statements and shown as at the date of the Statement of Financial Position (previously called the Balance Sheet).

Documenting the historical development of the funds which were put together to establish the EIF and, in particular, tracing the evolution of previous investments held by the European Scout Foundation on behalf of the Region since 2000, delayed the production of the financial statements till a period when the Auditors could reschedule some of their work. This, along with some delays in the production of the consolidated accounts for the World Organization, has resulted in a significant delay in finalising the annual accounts and communicating them to you.

At all stages I have monitored closely the audit, and was myself involved in a meeting to clarify the reporting position of the European Scout Foundation regarding the EIF and how this could be reported within the accounts of the Region.

As Regional Treasurer I will be happy, with the Regional Director, to answer any queries you may have concerning the final audited accounts for the year ended 30 September 2011.

As an addendum to the published accounts, I am also pleased to advise the success of our fundraising activities in support of the Region and NSOs. I am sure that you, like me, will recognise the importance that this additional income makes to the operations of the Region and our member organisations.
