### • AC 8.1.1 - ACHIEVED

Encourage NSOs/NSAs to participate in the creation and development of National Youth Councils

### **Progress:**

- Organized a meeting of NYC representatives at YFJ COMEM
- Co-organised the Network meeting for Representatives with more than 60 participants from Europe and Eurasia
- Continued monitoring of the work of YFJ in this regards, in order to approach and offer support to NSOs.

"European Steering Committee for Youth (CDEJ) calls on the European Youth Foundation (EYF) to examine Volunteer Time Contribution as in-kind contribution within supported projects and activities. At the same time, the Programming Committee together with the EYF secretariat is kindly asked to develop, by the next CMJ meeting, a proper tool for measuring volunteer time using (but not necessarily to limiting it to) the experience of existing mechanisms in this regard (e.g. the European Youth Forum's method, the ILO Manual on the Measurement of Volunteer Work)."
