# Call for Partner to join funding project: Youth worker mobility

Dear International Commissioner,

For 3 years, the European Regional Office has applied successfully for a European Union grant for "Youth worker mobility" within the programme Youth in Action. This grant allowed one youth worker from a National Scout Organisation/National Scout Association to experience the work of funding and external relations in the WOSM Brussels office for 6 months while supporting the work of the sending organisation also in these areas.

## The objectives of this project:

1) Contribute to the personal and professional development of a young youth worker by giving them the opportunity to experience the European dimension of youth work by contributing to the activities of the Brussels Regional Office in external relations and funding;

2) Deliver support and strengthen cooperation with an NSO/NSA on specific identified topics such policy development, funding and to reinforce the European dimension within the sending organisation;

This project should be seen as a good opportunity for the National Scout Organisations and National Scout Associations to strengthen their external relations and funding and therefore should answer to a need indentified by the NSO/NSA.

#### What costs can be covered by the grant?

70% of the travel costs of the Youth worker to reach Brussels;

A weekly allowance for the youth worker of 350 Euros.

## When the project should start?

The project should start on 1 January and the Youth Worker is expected to be in Brussels from 1 February until end of July 2014.

### Eligible countries to this grant:

Please note that besides all the EU countries also NSOs/NSAs from the following are eligible to become partners: Iceland, Liechtenstein, Norway, Turkey and Switzerland.

If your organisation is interested to be a partner to this project, we will kindly ask you to fill in the "Declaration of interest" (Annex A) attached and to send it back to <u>mpotard@scout.org</u> by 15 August. In order to be able to fill in this declaration of interest, the youth worker should be already indentified.

The selection of the NSO/NSA will be made on the basis of the analysis of their need. After 15 August, the organisation selected will be contacted to provide further documents that are requested for the proposal. The project will be submitted no later than 4 September so the NSO/NSA selected will be requested to send the information needed in due time, right after its selection.
