ERASCOUT – European mobility programme open to WAGGGS Member Organizations (M EGC 09)

The European Guide Conference:

Acknowledges that young people are increasingly tending to travel throughout Europe as part of their studies or their linguistic and occupational training. Immersion in, and adaptation to, a foreign country is a time-consuming and often complex process. However, the young people involved often express their desire to continue their involvement as citizens of Europe through their membership of the Scouting and Guiding Movements, among other pursuits;

Acknowledges that in response to this reality, Member Associations and Organisations have for some considerable time encouraged the hosting and transfer of 17- to 25-year-olds studying or training abroad (for extended periods of time) under the following projects: Erasmus Scout (Belgian Non-profit Scouting Associations), ErasmuScout (AGESCI Italy), Scoutasmus (MEC Catalonia), Scout Erasmus (MSC Spain), Escout (CNE Portugal), Erascout (SGDF France);

Is convinced of the value of these educational processes and opportunities, which allow young people to more easily integrate into the host country, can enhance their employability, and support the vision of a more peaceful world, one which is more welcoming of differences;

Is convinced that this opportunity offers young adults a way to pursue their scouting/guiding activities and to experience the local scouting and guiding associations;

Acknowledges that the European institutions nowadays wish to facilitate youth exchange arrangements to the maximum, for both students and professionals, via such systems as funding programmes for youth and mobility or EU flagship initiatives such as "Youth on the Move;"

The European Guide Conference recommends that the Europe Region WAGGGS:

Provides a space on europe.wagggsworld.org websites, europak, where young people who are interested can contact Member Organisations; and

Support and publicise this move via various events and through available communications channels.

Engage with European institutions to promote this opportunity to policy makers at European and national level.

The European Guide Conference:

Considering and acknowledging the encouragement received from past World Conferences urging Member Organizations and Component Associations to review their youth programme for adolescents and young adults to ensure that it provides challenging opportunities for leadership and personal development within and outside Guiding;

Reaffirming the contents and the values expressed through leadership contributing to the development of young people in achieving their full physical, intellectual, social and spiritual potential as individuals, as responsible citizens and as members of their local, national and international communities;

Acknowledging that Leadership is a process by which knowledge, skills, values and attitudes are fostered, individuals empowered and the learning spirit within the organization promoted and upheld;

Recognizing the importance of finding ways to help Member Organizations and their Component Associations to promote within their youth programmes the leadership qualities in young people that will be needed if they are to take an active and responsible role in modern societies;

Believing in the value of working together to achieve common goals, to share knowledge and skills, and most importantly, to respect and complement each other's skills, following the educational model of Baden Powell, who made use of the patrol system;

Recognizing the value of the work done to develop leadership, especially through the WAGGGS Leadership Development Programme (WLDP) that already recognizes diversity of leadership styles through a specific module on Leading Teams. There is also an e-learning programme on leadership within teams, which already focuses on this issue;

Considering that WAGGGS Europe Region is offering Member Organizations means and ways to promote the diversity existing in the Region and that leadership – a continually evolving concept, as stated in the WLDP – should be complemented with the spirit of teamship in order to better tackle such diversity.

Considering the high educational level of WAGGGS' programmes, a WLDP made more inclusive by embracing the spirit of teamship within leadership could become an educational tool even better suited for SAGNOs, which are compelled to harmonize various inputs in this sector.

Recommends that the Europe Committee WAGGGS

Consider the concept of social leadership enhanced by the spirit of teamship in all programmes where youth empowerment and youth involvement are developed.

Report to the next Conference on the progress made towards the development of this expanded concept of leadership on youth involvement in decision-making processes within the Region and how to continue this process.

WAGGGS Europe Region and Committee start by involving ICCG, with which a firmly established relationship already exists, and also other potential networks representing other faiths and beliefs, and platforms on the development of the spiritual dimension when working on issues concerning spiritual education,

For the education for spiritual development, the Europe Region WAGGGS and its Committee actively involve groups and forums / platforms working on issues of faith, beliefs and development of the spiritual dimension.

In collaboration between the Europe Region WAGGGS and all of these groups and forums/platforms, the spiritual content and animation at regional events WAGGGS or WAGGGS/WOSM (Roverway, Academies ...) is developed together with Member Organizations in charge of organizing these events.
