# 40<sup>th</sup> World Scout Conference, European Region Meetings

# Monday, 11 August 2014 & Friday, 15 August 2014

### Dear Friends,

The World Scout Conference is WOSM's governing body and is composed of all members of the World Organization: the National Scout Organizations. Its function is to consider policy and standards of the Scout Movement throughout the world, formulate general policies of the World Organization, and take the necessary action to further the goals of the Movement.

"Shaping a common future" will be the theme of the 40<sup>th</sup> World Scout Conference. As the theme suggests, the agenda of the Conference will include discussions on the WOSM Vision 2023, as well as projects and major topics and proposals, while looking into the future. NSOs will also be given the opportunity to meet in Regional Groups as before. Two Regional meetings have been foreseen during the Conference; one at the beginning and the second at the end.

The European Scout Committee, responding to the request of many NSOs to provide a time slot to discuss further the main topics included in the agenda of the World Scout Conference, has allocated the first of the two Regional meetings for this purpose. The second regional meeting will be focused on the specific work of the European Scout Region; highlights on the work done after the Regional Conference in Berlin, in brief the implications of the World Conference, as well as what will follow in the Region.

## The first Regional Meeting: from Curitiba to Ljubljana

The European Scout Committee has identified the key topics for which separate sessions will be held during the *first Regional meeting*. The role of the European Scout Committee during these sessions will be **only** to facilitate.
