Skills for Life: Scouting and Guiding, a cost effective answer Debate and workshop 25th of February, Brussels

In the frame of the "Donor Advocacy" project WOSM and WAGGGS invite you to participate in a debate on how youth organisations are contributing to address current priorities of Europe 2020 such as soft skills education, fighting unemployment and fostering active citizenship; based on the finding of studies of social and economic impact of Scouting and Guiding in different countries as well as a survey on challenges and good practices around funding. The event will be held on Wednesday 25 January at the European Economic and Social Committee.
