- The preparations for the Educational Methods Forum, taking place in May 2015, are well underway and the planning team has held two live meetings and several virtual meetings (Objective 1, KPI 1)

- A survey mapping co-educational practices has been sent to NSOs and a good number of answers has been received. Based on the results, we have reviewed our actions related to this specific, co-education related objective of the Regional Scout Plan (Objective 2, KPI 2)
- Juho participated in the ICT Network Meeting 6th-8th February 2015 in Prague and ran a workshop on how the Network could support fulfilment of various regional objectives, including EMCG objective 3. In the event Juho also ran a pecha kucha presentation about utilizing membership data in youth programme development (Objective 3, KPI 3)
- A project group has been created to tackle this particular objective, consisting of members of the ICT Network volunteers (Objective 3, KPI 3)

- In the All Groups Meeting in Budapest (January 2015) we were able to remove some actions from the Regional Scout Plan, that did not really serve any real purpose. This clarified many things for us and made us feel better about the plan
- Saad Zian joined the group in Budapest meeting and will provide us with high-level expertise on adult resources / volunteer management

- We have been asked to support a EU-funded project on Global Development Education, put together many NSOs and other NGOs from different countries. The exact form of support is not clear yet but we are negotiating with Marguerite Potard about the practicalities.
- The Youth Department of the Council of Europe is launching a call for participants for TRAYCE - Training of Trainers for Youth in the Council of Europe, a long-term training of trainers in non-formal education with young people. The training course aims to support the quality development of non-formal education activities in the Council of Europe through the development of competence of trainers active in the youth field. The training course will start in April 2015 and include different learning features (residential seminars, online learning, practice phases etc.). The interested candidates must apply before 10 March.

7. Issues for the consideration of the European Scout Committee

- The next Training Commissioners Network Meeting (TCNM) has been proposed already for late 2015. We think it would make more sense to have it in April/May 2016 and get a partner country for applying funding from Erasmus+.
- We think it would be a worthwhile effort during this triennium to complete the Management of Volunteers in Scouting (MOVIS) toolkit (<http://euroscoutinfo.com/movis-resources/>). As we see it, the best way to accomplish this would be to have it done as project-based intern work or have a group of volunteers work on this during a "wild working weekend". However, there is currently no money budgeted for this during this fiscal year so this might be hard to accomplish.
