## NSO support for achieving the Regional Scout Plan

Dear friends,

Before the Regional Conference in June, we had an open call in order to gather interest of volunteers to support the Committee as it delivers the Regional Scout Plan. That Open Call ended on 15 July. A small number of late applicants were retained and only used if there were no viable alternatives.

The process adopted was to appoint Coordinators for the 5 areas of the Operational Framework. This was conducted in conjunction with our Volunteer Management team, relevant committee members and related staff.

Then the Team Leaders were appointed involving additionally the Coordinators.

Then the Team Members were appointed involving also the Team Leaders.

At each stage contact was directly made with the applicant to verify certain information and to outline the role envisaged.

Unfortunately, the process has taken us significantly longer that we anticipated and while we still have a few spaces to fill, we are nearing the end of this phase in the operation. We sincerely apologise that our initial communication to applicants at the end of August had an unrealistic time line of appointments being made before mid-October.

We have noted the deficiencies, as well as the positive aspects of the process, and this will be reviewed thoroughly by the Committee and the Continuous Improvement area of our work so that next time we will be more streamlined and faster to meet our objectives.

Thank you for your understanding of this situation and for your continued support of what we are trying to achieve.

You will be interested to note that we received 133 applications, on time. From these, we are pleased to advise the following appointments contained in the attached paper have been made.

Once again, thank you and your volunteers for the interest and the patience you have shown. A message will be sent to all remaining applicants advising them of the process. We remain at your disposal should you have further questions.
