#### Description and objectives of the Network Meeting 2017

The Network Meeting is a yearly appointment for Guides and Scouts that are representing their NSOs/NSAS/MOs/CAs in various platforms/organizations including their National Youth Councils.

100km and 499km:	EUR 180 per participant
500km and 1999km:	EUR 275 per participant
2000km and 2999km:	EUR 360 per participant
3000km and 3999km:	EUR 530 per participant
4000km and 7999km:	EUR 820 per participant
8000km and more:	EUR 1300 per participant

Travel distances will be calculated by WAGGGS using the <u>distance calculator</u> of the European Commission. The KM calculation refers to a one-way travel from their place of residence to the venue of the activity. WAGGGS will take the capital city as departure point. # ANNEX I

Get a PIC for an Erasmus+ application

To be able to be a partner in an Erasmus+ programme, it's mandatory that you have:

- a EU login account
- a PIC number: the 9-digit Participant Identification Code (PIC) to identify your organisation as an economic entity for Erasmus+ applications.

Please note that if your organisation is already registered, you do not need to register again.

# 1) Register on EU login

You will first need to register your organisation on EU Login (formerly ECAS): <u>https://webgate.ec.europa.eu/cas/eim/external/register.cgi</u> We advise you to consul the <u>European Commission's manual</u> (2.64 MB) on EU Login.

### 2) Get a PIC number

Register your organisation to obtain a unique 9-digit Participant Identification Code (PIC). We recommend that you read the <u>Participant Portal user manual</u> before you register.

Please keep the basic legal data of your organisation at hand to facilitate the registration.

You must submit two documents: legal entity of your organisation, and details of the bank account.
