Scouts and Scout leaders in National Scout Organisations (NSOs) within the European Region are invited to join the 1st Annual European Scout Photo Contest - 2018.

Photo entries should be received by the World Scout Bureau Europe Support Centre Brussels not later than 31 July 2018.

RULES

What photos?

Photos must have a title and show the theme "*Scouting and the Community*". All entries should be in digital copy and resolution must be 300 dpi (dots per inch). Any entry less than the required resolution and size will not be accepted as the winning entries will be used in regional publications. You may submit JPEG or EPS files.

Who can participate?

Scouts and leaders registered with a National Scout Organisation in the European Region.

Needed information

- Name, date of birth and email of author
- National Scout Association
- Holder of copyright
- Title of the photo
- Date and place of the photo

Where to send?

To the World Scout Bureau Europe Support Centre Brussels endorsed by the National Scout Organisation in the country (International Commissioner). An entry without endorsement of the NSO will not be considered an official entry.

Send it to the following email address – <u>comms@scout.org</u> - while putting in copy (cc) the International Commissioner of your Association. International Commissioners will be later contacted to confirm their endorsement.

Who selects the winners?

An international panel of professional photographers.

What are the prizes?

Awards will be online gift vouchers to purchase photography-related gadgets as follows:

Gold: € 200 voucher Silver: € 100 voucher Bronze: € 50

Rights

- All photo entries shall not be returned.
- The right to use the photos for publication, exhibition and other Scout activities belongs to World Scout Bureau Europe Support Centre. Candidates must have full copyright ownership of the photos they share
- Consent: In compliance with the EU data protection regulations, all candidates should complete and sign the following consent forms:

Parental consent form: this is to be completed and signed by the parent or guardian of all individuals who are under 16 years old, depicted in photographs.
