Dear Friends,

This circular provides you with information on the next application for which your MO & NSO/NSA can be a partner for the ***Guides and Scouts lead the way on Refugee Inclusion***.

Five years after the refugees' situation peak it is time to analyse how Guiding and Scouting in Europe reacted to it in order to further improve our actions and hopefully become even more open and inclusive towards migrants in our associations.

The specific objectives:

The forum is aiming to provide a space to analyse the state of art of Guiding and Scouting in reaching out to migrants by offering an innovative training and sharing experience to the participants.

- Reinforce the needs of and raise awareness about integration of migrants in Guiding and Scouting membership
- Offer high level training on migrants integration in collaboration with external partners
- Facilitate the sharing of experiences and best practices between MOs/NSOs/NSAs
- Develop samples of migrants integration schemes to be applied by the participants and possibly replicable in national contexts
- Experiment an innovative training "solution oriented" methodology

The expected outcomes:

The event will apply an innovative "Hackathon style" methodology that will engage the participants directly in identifying solutions to a challenge offered by the organising team: "Develop an effective migration integration scheme in Guide and Scout Associations". Each of the international teams will come up with a proposal for an integration scheme for Guides and Scouts organisations that could be then applied and adapted to national contexts.

Participant Profile:

The key actors in MOs/NSOs/NSAs that participate in the creation of national programmes/policies, including:

- Programme Commissioners
- Training Commissioners
- Diversity & Inclusion national contacts
- Senior volunteer working with people with Refugee backgrounds

There is no age limit for taking part in the event but it is recommended that associations follow the European Youth Forum's age limit and select participants under the age of 35. Participants should be available for the entire duration of the event.

As gender balance and gender equity is one of our working priorities, we will take it into account in the selection process.

Date & venue:

End of March/beginning of April 2019, Greece

The event will start on Friday morning. If possible, participants are expected to arrive on Thursday evening and to leave on Sunday at lunch time.

Further details on the venue will be shared in due course

Programme & Languages:

The programme will be detailed later.

Participants may be asked by the organizers to assist in the facilitation of training sessions according to individual experiences and interests.

The event will be run in English with participants assisting with translation (into French) as required.

Participation Fee:

As participants travel expenses are covered up to a lump sum calculated on the travel distance for each participant, the latter (from the MOs/NSOs that are partners to the Erasmus + application) have a reduced participation fee per person.

Reduced fees travel details:

100 and 499 KM	180 EUR per participant
500 and 1999 KM	275 EUR per participant
2000 and 2999 KM	360 EUR per participant
3000 and 3999 KM	530 EUR per participant
4000 and 7999 KM	820 EUR per participant

For the purpose of this application, please note that all the distances will be calculated from the capital of your country. If you wish to indicate another departure point, please inform Sonia Abbondio at sonia.abbondio@waggs.org.

Insurance:

The Europe Region WAGGGS do not cover the participants for insurance neither during the event nor during the travel to or from the venue. Please note that it is the exclusive

responsibility of the MO/NSO to check and make sure that participants are covered by insurance (illness, accident, hospital, repatriation).
