These will then be combined, translated and circulated to delegations on Sunday 25 August 2019.

Amendments to these recommendations and any proposals for amendments concerning the work in partnership will be accepted until Monday 26 August at 19.30 CEST. Please find attached document templates for Draft Recommendations and Proposals for Amendments. These are also available on the [Conference website](#).

Please note that Draft Recommendations submitted to the 16<sup>th</sup> European Guide and Scout Conference can also be submitted to the 16<sup>th</sup> European Guide Conference and the 23<sup>rd</sup> European Scout Conference. Associations wishing to do so should conform with the relevant procedures for the respective separate conferences.

Draft Recommendations and Proposals for Amendments must be signed by each WAGGGS Member Organisation (MO of WAGGGS) and National Scout Organisation (NSO of WOSM) in the Joint National Delegation before being submitted to the Recommendations Committee. Two signatures are required when Draft Recommendations or Proposals for Amendments are submitted by an association which is member of both WAGGGS and WOSM (so-called SAGNOs).

It would be appreciated if Draft Recommendations and Proposals for Amendments can be submitted electronically to reduce waste. Please make your submissions to [recommendations16egsc@europak-online.net](mailto:recommendations16egsc@europak-online.net) using the templates provided in Annexes A and B.
